

#### **Pentair Education Fund**

In agreement with Pentair, a Pentair education fund has been established for CVIPSSA members. Twenty-five percent (25%) of the annual rebates given to our chapter by Pentair will be set aside to reimburse our members for Pentair training fees/tuition. The maximum amount to be set aside is \$1,000 per year. If the reimbursement requests exceed the education fund amount, then the fund amount will be split amongst the members that applied for reimbursement. #### A Message from Monte...

#### **Freezing Temperatures**

Be prepared for freezing temperatures that are sure to be on the way. Everyone knows what a freeze can do to pool equipment that sits idle, remind your clients to insulate the equipment pad and be prepared to run the equipment during the coldest period of the day. Ideally the pumps are equipped with temperature sensors to avoid any damage if temperatures get too low. However, most pipe related freezing issues do not involve pool plumbing systems.

In the Sacramento area we do not have an issue with pipes freezing underground, most of the problems are above ground with exposed pipes. When a pressurized water line freezes, it is not the ice forming in the line that bursts the pipe, rather it is the pressure that forms inside the pipe between the expanding ice and a closed faucet. The rupture usually occurs at the weakest point in the plumbing system. Obviously it is a good idea to insulate any exposed exterior main lines, irrigation valves, and faucets. Use insulated hose-bib covers, wrap main lines at the house service, cover and insulate all irrigation valves, use pressure relief valves on exterior faucets, disconnect all hoses from hose bibs. During extended cold spells, do not turn the heat off in your home, especially if going out of town. Pipes in ceilings and attics can freeze if the interior temperature in the home or attic gets too low. Leave a faucet open with a slow trickle to relieve any pressure that may build in the line if ice forms.

We are fortunate to have fairly mild winters, most of the time, and do not have a serious issue with freeze damage. Having said that, I am already looking forward to Spring and some warmer weather!

#### Water Boatman in Your Pool?

Contrary to what the homeowner might believe, it does not mean you are doing a bad job. According to a recent article in the *Service Industry News*, the heavy rain last year triggered a lot of plant growth, which encouraged a high population of boatmen bugs this season.

If you have them, then you know they are fast and it can be challenging to get rid of them. One option discussed in the article was to add a little oil to the pool, which suffocates the bugs and they drown. Another option was to add some liquid dish soap. The soap releases the water tension (surfactant) and the bugs can't trap air bubbles and breathe. These options are not recommended as they negatively impact the water chemistry. The preferred option was to use an algaecide that contains benzalkonium chloride, followed by a 60% polymer algaecide. The benzalkonium chloride is a surfactant, which releases the water tension, and the poly 60 algaecide kills the algae that the boatman eat.

Qualified pool pumps and motors must have been purchased and installed by 12/31/17.
