I would like to wish all our members and chapter supporters a Merry Christmas and a Happy New Year!!

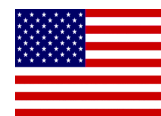
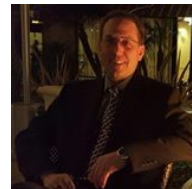

Have a safe and great Christmas and New Year!

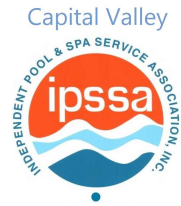

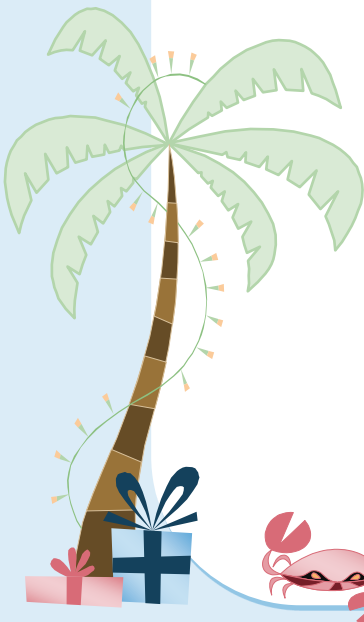
