Have a great January!

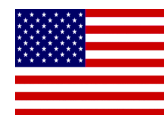
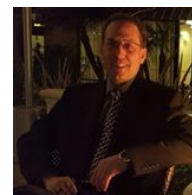
Happy New Year to all our members and chapter supporters!!

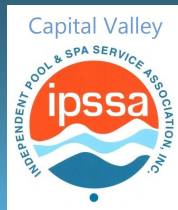

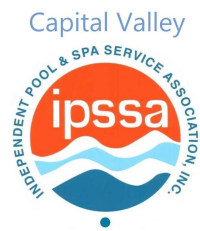
